

END-USER LICENCE AGREEMENT CAR NAVIGATION DATA

NOTICE: Permission to load and/or use the map data ("the Product") supplied by NavNGo either on CD-ROM, SD card or within a Car navigation device is conditional upon You agreeing to the terms set out below and abiding by those terms. Do not load or use the Product until You have read and accepted all the terms of this agreement and wish to become a licensee of the Product. Acceptance will bind You to the terms of the agreement. By loading or using the Product You will be deemed to have accepted the terms of this agreement and to be bound by them. If You do not wish to accept the terms, then You should return the Product to the person from whom the Product was purchased without using it.

1. SCOPE OF LICENCE
 - 1.1. Title to the Data is not transferred to You. Ownership of the copyright and other rights in the Data remains vested in GeoSmart, subject to the rights granted to You under this Licence. All other rights are reserved
 - 1.2. NavNGo grants to You a personal and non-exclusive right to use the Data on a single compatible GPS car navigation device purchased by You from NavNGo on the condition that You strictly observe all of the terms and conditions set out in this Licence. Any other use is prohibited.
 - 1.3. You do not have the right to sub-licence Your rights under this Licence. You may assign Your rights under this Licence only in accordance with clause 2.3. No other transfer, assignment or disposition of Your rights under this Licence shall be permitted.
 - 1.4. You shall not copy, reproduce, translate, reverse engineer, modify, reformat, distribute or publish the Data or remove any proprietary labels or notices from the Product or its packaging or permit any third party to do so for any purpose.
2. REGISTRATION AND TRANSFER OF RIGHTS
 - 2.1. Before using the Product, You are required to register by providing such details to NavNGo as NavNGo may reasonably require to identify You as a licensed user of the Product. You will provide such details (and updated information) to NavNGo and/or GeoSmart promptly upon request. If You are an individual (ie, a natural person) You have rights under the NZ Privacy Act 1993 to access and request the correction of any personal information which NavNGo or GeoSmart holds about You.
 - 2.2. You agree that any personal information You provide to NavNGo under clause 2.1 may be disclosed by NavNGo to GeoSmart.
 - 2.3. Your rights under this License to use the Product may be assigned:
 - 2.3.1. to any person who acquires legal title to the car navigation device on which the Product was first used is installed, provided that such person registers with NavNGo in accordance with clause 2.1 before using the Product; or
 - 2.3.2. where both NavNGo and GeoSmart give their prior written consent to an assignment (which consent may be given or withheld at their absolute discretion), provided that any conditions to which such consent is subject are strictly complied with.
3. UPDATES
 - 3.1. Unless requested otherwise by You, NavNGo and/or GeoSmart shall have the right to offer to You with updates to the Product from time to time at the price and on the terms and conditions determined by NavNGo. Your use of any update provided will be subject to the terms of this Licence.
 - 3.2. NavNGo and/or GeoSmart may require you to return the Product as a condition of You receiving an update under clause 3.1.
4. INTELLECTUAL PROPERTY RIGHTS
 - 4.1. You acknowledge that the Data is subject to copyright and other intellectual property rights. These rights belong to GeoSmart. You shall not during or any time after the expiry or termination of this Licence permit any act which infringes that copyright or other intellectual property right and You will fully indemnify NavNGo and GeoSmart against all liabilities, costs and expenses as a result of your breach of this Licence.
 - 4.2. You must immediately notify GeoSmart if You become aware of any event referred to in clause 1.4 or act which infringes that copyright or other intellectual property right of GeoSmart.
5. WARRANTIES
 - 5.1. You agree that the NZ Consumer Guarantees Act 1993 ("CGA") does not apply if the Product has been acquired by You for business purposes.
 - 5.2. Where You have not acquired the Product for business purposes: (a) You acknowledge that NavNGo and GeoSmart do not provide any Express Guarantee (as defined in the CGA) other than those expressly confirmed by NavNGo and/or GeoSmart; and (b) NavNGo and GeoSmart reserves the right to replace the Product or to refund the price paid for the Product (at their option) if it fails to comply with any guarantee contained in the CGA.
 - 5.3. Nothing in this Licence is intended to have the effect of contracting out of the provisions of the CGA except to the extent permitted by that Act, and these terms are to be modified to the extent necessary to give effect to the intention.
 - 5.4. Except for any rights you may have under clause 5.2 and under any express term of this Licence, all guarantees, warranties, descriptions, representations or conditions whether expressed or implied by law, trade, custom or otherwise are expressly excluded to the maximum extent permitted by law.
6. LIMITATION OF LIABILITY
 - 6.1. To the extent that the liability of NavNGo and GeoSmart under this Licence is not otherwise limited or excluded and to the maximum extent permitted by law, the total liability of NavNGo and GeoSmart whether in tort (including negligence), contract or otherwise, for any loss, damage or injury arising directly or indirectly from any defect in the Product or any other breach of NavNGo or GeoSmart's obligations under this Licence is limited to the lesser of:
 - 6.2. the price paid by You for the Product; or
 - 6.3. the cost of repairing or replacing the defective Product; or
 - 6.4. the actual loss or damage suffered by You (excluding any loss or damage of the type referred to in clause 6.2).
 - 6.5. Notwithstanding any other provision of this Licence, under no circumstances will NavNGo or GeoSmart be liable for any loss of income or profits or any consequential, indirect or special damage or injury of any kind suffered by You or any other person.
7. TERMINATION
 - 7.1. This Licence will terminate immediately without notice and without prejudice to the remaining legal rights of NavNGo and/or GeoSmart if You fail to comply with any term or condition of this Licence.
 - 7.2. Upon termination, NavNGo and/or GeoSmart will be entitled to demand that You immediately return the Product.
8. GENERAL
 - 8.1. Failure or delay by NavNGo and/or GeoSmart in enforcing any right or provision of this Licence is not to be deemed a waiver of such provision or right with respect to any breach.
 - 8.2. This Licence shall be governed by New Zealand law and the parties submit to the exclusive jurisdiction of the New Zealand courts.
9. DEFINITIONS
 - 9.1. In this Licence:
 - "NavNGo" means Nav N Go Kft. and any person to whom it lawfully assigns its rights under this Licence.
 - "Data" means the mapping data contained on the CD-ROM to which this Licence relates.
 - "GeoSmart" means GeoSmart Maps Limited and its successors and assigns.
 - "Licence" means this end user licence agreement.
 - "Product" means the Data, CD-ROM, packaging and user information.
 - "You" or "Your" means the person first registered as the user under clause 2.1 (or the person to whom the rights are transferred under clause 2.3).
